Water Underground believes that every human being deserves access to life's most basic necessity - clean water. Our mission is to use access to clean water, sanitation, hygiene and agricultural innovation as the building blocks to enable communities in the most vulnerable rural areas of Mozambique to lift themselves out of poverty and launch themselves into development. We equip communities with the education and quality infrastructure they need to become empowered and take ownership of their community's future.

In 2017, 6 new community water projects were completed by Water Underground. 4 of the projects were funded by a Global Grant from Rotary International and the remaining funding was provided through donations from private foundations and individuals of the public.

Projects were centered in the schools of the following villages in Massinga District, Inhambane Province, Mozambique: Chilubuane, Nhabacal, Chivaquene, Mavume, Macangane and Catine. In each community a clean water well, school sanitation center, large community garden with drip-irrigation and 2 months community training was provided. Ongoing monitoring and evaluation has continued since completion of the projects for transparency and continued improvement of the program.

Community Led Total Sanitation was added to our Water, Sanitation and Hygiene program and we achieved 100% latrines in all homes in the 6 communities we worked.

In 2017, Cyclone Dineo destroyed some of the infrastructure in the schools of our 2015 and 2016 projects, including damage to the sanitation centers, the gardens and the classrooms. All children lost their books and school equipment.

Water Underground did an appeal for public donations to help the devastated schools recover and to rebuild our infrastructure. New school books were donated to all the children, as well as soap to each family to prevent disease spreading from flood waters. Corrugated metal and other basic building materials were donated to schools where Water Underground projects had previously been completed to help rehabilitate our schools and repair the infrastructure from our past projects.
